Provide emergency shelter & meals to families with children through collaboration with a network of interfaith congregations. Families can stay in the Shelter Program for up to 90 days, during which time they receive counseling and support, seek & secure employment, learn to manage cash flow with the objective of securing employment and permanent housing. 34 families, consisting of 46 adults and 81 children were served during the year. 4851 shelter days and 12,955 meals were provided through the interfaith network (estimated value \$124,825). 83% of program graduates secured housing. During the year, the organization continued to work on expanding the network of interfaith congregations participating in hosting families to increase the capacity for serving the homeless families with children.

Families from the emergency shelter program, who succeed in gaining employment, are eligible to move into our Transitional Housing units for up to 6 months. During their residency, they continue to work with our counselors to reinforce cash flow management skills, maintain employment and save money. By the end of their stay, they have the income, resources and skills to move onto permanent housing and maintain their self-sufficiency. During 2011 2,370 housing days were provided to 29 individuals who rotated through the Transitional Housing program.
