SHELTER PROGRAM: PROVIDES EMERGENCY SHELTER AND SUPPORT SERVICES TO FAMILIES WITH MINOR CHILDREN AND THEIR PETS WHEN EXPERIENCING HOMELESSNESS. LODGING IS PROVIDED THROUGH COMMUNITY-BASED HOSTING WITH AN INTERFAITH NETWORK OR ON-SITE AT FAMILY PROMISE. THERE ARE ROTATIONAL AND COMMUNAL HOUSING OPTIONS AVAILABLE, BOTH OF WHICH ARE 60 DAYS. STEPUP AND BRIDGE HOUSING OPTIONS ARE FOR A MAXIMUM OF 90 DAYS. PROGRAMMATICALLY, FAMILIES RECEIVE SHELTER, BASIC NEEDS, COACHING, EDUCATION, CASE MANAGEMENT AND CASH FLOW TRAINING AT ONE OF FIVE FAMILY PROMISE SITES. THE GOALS ARE TO REPLACE ANY MISSING VITAL DOCUMENTS, ENROLLMENT IN SOCIAL PROGRAMS FOR WHICH THEY ARE ENTITLED (I.E., DES FOR CHILDCARE, SNAP, MEDICAL INSURANCE, SOCIAL SECURITY, DISABILITY, TANF, UNEMPLOYMENT, CHILD SUPPORT), EMPLOYMENT, ENROLLMENT OF CHILDREN

OUTREACH DEVELOPMENT: IN ORDER TO PROVIDE EMERGENCY SHELTER TO HOMELESS FAMILIES, THE ORGANIZATION MUST ENSURE A SOLID AND DIVERSE AWARENESS AND FUNDING PIPELINE. REACHING OUT TO THE CONGREGATIONAL, BUSINESS, AND CIVIC COMMUNITIES ARE ROUTINE EFFORTS. CONGREGATIONAL VOLUNTEERS WHO PROVIDE LODGING AND MEALS REMAIN THE CORE OF FAMILY PROMISE. THESE RELATIONSHIPS ARE THOUGHTFULLY CULTIVATED AND NURTURED TO SUSTAIN THEIR PARTICIPATION, ESPECIALLY IN A POST-PANDEMIC WORLD WHERE CHURCH ATTENDANCE HAS SLID. IN-KIND LODGING, MEALS AND VOLUNTEER EFFORTS SAVED FAMILY PROMISE OVER \$590,000 IN 2025. THE OUTREACH STAFF CONTINUES TO EXPAND COMMUNITY PARTNERSHIPS IN TRADITIONAL EMERGENCY SHELTER AND TO GENERATE OTHER WAYS TO CREATE MORE AFFORDABLE TEMPORARY AND PERMANENT HOUSING.
